TREE REMOVAL INFORMATION

STATE REGULATIONS

Pursuant to Public Resources Code (PRC) 714 the California Department of Forestry and Fire Protection (CAL FIRE) is responsible for the enforcement of the Z'Berg – Nejedly Forest Practice Act. The Act allows for the harvesting of trees for commercial purposes on all non-federal timberland in California, and included in these regulations is the removal of naturally occurring commercial tree species from forested lots, areas of pending new construction, and from around existing structures. In Modoc, Lassen and Plumas Counties "commercial species" includes Ponderosa and Jeffrey Pine, Sugar Pine, Red and White Fir, Douglas fir, and Incense Cedar.

The following most commonly used harvest documents are exempt from the Timber Harvest Plan (THP) preparation and submission requirements, hence why they are called exemptions. It is important to note, however, that whether being conducted under a THP or an exemption, timber operations must be conducted in conformance with the California Forest Practice Rules. These exemptions are free of charge from CAL FIRE and are submitted to CAL FIRE in Redding for review and approval.

1. Structure Protection Exemption

This exemption is required only if the wood is to be sold, bartered, exchanged, or traded, and is required for the removal of selected trees located within 300 feet from an existing legally permitted structure. Registered Professional Forester (RPF) services are required if trees are going to be removed within 150-300 feet from the structure, but not required if tree removal stays within 150 feet of the structure. A Licensed Timber Operator (LTO) must be listed on the exemption and is responsible for all logging activities including the treatment of logging slash created by timber operations. Clearcutting is not allowed and the post-harvest stand shall be composed of healthy and vigorous dominant and codominant trees. CAL FIRE has up to 5 days to approve the exemption and once approved the exemption is valid for 1 year.

2. Christmas Tree; Dead, Dying, Or Diseased; Fuelwood Or Split Products Exemption

This exemption is required only if the wood is to be sold, bartered, exchanged, or traded, and is required when removing trees that are dead or are obviously dying from insect attack or disease, or when removing fuelwood or other miscellaneous products such as Christmas trees, chips, poles, etc. The harvest cannot exceed 10% of the average volume per acre. Registered Professional Forester services are not required, but a Licensed Timber Operator must be identified on the exemption and is responsible for all logging activities including the treatment of logging slash created by timber operations. This exemption is valid for 1 year.

3. Less Than 3 Acre Conversion Exemption

This exemption is required for property owners who intend to remove trees for land uses other than the growing of commercial tree species. This applies to those who plan to remove trees for the construction of residences, driveways, outbuildings, septic systems, solar panels, vineyards, orchards, and gardens in preparation for such development. **This exemption is required whether or not the trees are sold, bartered, exchanged, or traded.** This exemption must be prepared by a Registered Professional Forester and timber operations must be conducted by a Licensed Timber Operator. Building contractors are ineligible to perform this work unless they are a Licensed Timber Operator. CAL FIRE has up to 15 days to approve the exemption and once approved the exemption is valid for 1 year.

4. Forest Fire Prevention Exemption

This exemption is required only if the wood is to be sold, bartered, exchanged, or traded, and is required if the property owner wants to eliminate the vertical and horizontal continuity of vegetative fuels for the purpose of reducing fire rate of spread, duration and intensity, and fuel ignitability. This exemption must be prepared by a Registered Professional Forester and a Licensed Timber Operator (LTO) must be identified on the exemption. The LTO is responsible for all logging activities including the treatment of logging slash created by timber operations. CAL FIRE has up to 5 days to approve the exemption and once approved the exemption is valid for 1 year.

5. Drought Mortality Exemption

This exemption is required only if the wood is to be sold, bartered, exchanged, or traded, and is required when the property owner wants to remove dead and dying trees from their property in amounts greater than 10% of the average volume per acre. The service of a Registered Professional Forester is required if the trees are not currently dead, and if the project is greater than 20 acres in size. A Licensed Timber Operator must be listed on the exemption and is responsible for all logging activities including the treatment of logging slash created by timber operations. CAL FIRE has up to 5 days to approve the exemption and once approved the exemption is valid for 1 year.

Specific terms and conditions apply to exemptions, including logging debris clean-up requirements and protection of wildlife, archaeological sites, water quality, and other natural resources. Before hiring a Licensed Timber Operator (LTO), be sure to ask the LTO for proof of valid insurance or call CAL FIRE LTO Licensing at (916) 653-7211. A state filing fee is not imposed for the exemptions, however, the person listed on the form as the Timber Owner will be required to pay a post-harvest yield tax, based on the board foot volume of timber removed from the parcel, to the State Board of Equalization. Small amounts of timber may be exempt from yield tax. A complete listing of these and other CAL FIRE forms and information can be found on the Internet at:

Glossary – Abbreviations and Definitions

RPF – Registered Professional Forester

LTO – Licensed Timber Operator

PRC – Public Resources Code

CCR – California Code of Regulations

PRC 4526. Timberland. "Timberland" means land, other than land owned by the federal government and land designated by the board as experimental forest land, which is available for, and capable of, growing a crop of trees of a commercial species used to produce lumber and other forest products, including Christmas trees. Commercial species shall be determined by the board on a district basis.

PRC 4526.5. Timber operator. "Timber operator" means a person who is engaged in timber operations or who contracts with others to conduct the operations on his or her behalf, except a person who is engaged in timber operations as an employee with wages as his or her sole compensation.

PRC 4527. Timber operations.

(a) (1) "Timber operations" means the cutting or removal, or both, of timber or other solid wood forest products, including Christmas trees, from timberlands for commercial purposes, together with all the incidental work, including, but not limited to, construction and maintenance of roads, fuel breaks, firebreaks, stream crossings, landings, skid trails, and beds for the falling of trees, fire hazard abatement, and site preparation that involves disturbance of soil or burning of vegetation following timber harvesting activities, but excluding preparatory work such as treemarking, surveying, or roadflagging.

(2) "Commercial purposes" includes (A) the cutting or removal of trees that are processed into logs, lumber, or other wood products and offered for sale, barter, exchange, or trade, or (B) the cutting or removal of trees or other forest products during the conversion of timberlands to land uses other than the growing of timber that are subject to the provisions of Section 4621, including, but not limited to, residential or commercial developments, production of other agricultural crops, recreational developments, ski developments, water development projects, and transportation projects.

CCR 895.1 Commercial Species (For the Northern Forest District:) means those species found in group A and those in group B that are found on lands where the species in group A are now growing naturally or have grown naturally in the recorded past.
